
WHEREAS, notice of intention of Council to pass a bylaw has been given in accordance with Section 606 of the Municipal Government Act, and







#### **Current Public Works Activity**

- Culvert replacement on West Kerr Scheduled to take place from May 31 to June 02nd, 2021 has been postponed to June 07 to June 09 due to excessive water flow in creek.

With our revisions in and being reviewed we are currently awaiting the next steps from AEP. AEP has already asked for a few little things during the process but no full sit down meeting as of yet. Very fluid communication is being enjoyed at this time.

In essence, the system and project are approved, we are just agreeing to the terms upon which we will be measured going forward so there are no surprises after Approval is granted.

Mike is still gathering quotes, have been informed we will be ready for first meeting in June with a proposal.

BM Standpipe – was tabled in February awaiting more info. What I can say is it will require re-posting to the public and re-application for licenses with AEP for additional water and its use. We are currently working with Jeff Gutsell and AEP on finalizing all of our current licenses and Water Shortage Plan.

Heard from Council last meeting on desire and direction and we are still trying to find the best location and application for a quick solution that could also become a permanent infrastructure improvement for that area of the MD.

In January of this year, the MD received an application for an amendment to the Land Use Bylaw, for the purpose of developing a campground adjacent to the Water Reservoir.

The purpose of the proposed amendment is to allow for the development of a Seasonal Campground within Lot Dam Site B, Plan 2420JK. The lands are located adjacent to Waterton Reservoir, directly adjacent to the existing Provincial Recreation Area (Attachment No. 4).

The parcel is currently designated as Agriculture – A within the LUB. To accommodate a campground development, the parcel will have to first be redesignated to Rural Recreation 1 - RR1. The applicant has submitted the required fee and form for the process to begin (Attachment No. 1). The applicant has also supplied some supplementary information regarding the proposal (Attachment No. 2).

An amending bylaw, Bylaw No. 1324-21 has been prepared for Council's consideration (Attachment No. 3). If council gives First Reading of the bylaw, the date for the required public hearing can be set.





#### 1. Introduction

This plan is to accompany an application to re-zone this property from Agg to Rec-1.

#### 1.1 Location

NE28-04-27-W4 Located on the north shore of The Waterton Reservoir adjacent to the Waterton Reservoir Provincial Campground and Recreation Area, South East of Pincher Creek off Hwy 6.

#### 1.2 Conceptual Design

The land encompasses approximately 12 hectares (31.97 acres). The land use change is intended for a seasonal campground development comprised of 50-60 large (75' X 85') private lots in phase 1, and 50-60 large (75' X 85') private lots in phase 2.

#### 2. Existing Conditions and Land Use

#### 2.1 Existing Land Use

Currently the land is use for agriculture, mainly bulls during the winter months and remains in its natural state.

Land use in the immediate area include:

- Provincial campground/recreation area, day use beach, boat launch, and dock.
- Agriculture usage in the surrounding areas

Campground usage in this specific location is complimentary to the immediate area. There will be a minimal effect on the development of existing or potential recreation amenities in the area. Due to the proximity with the Provincial campground and rec area this should create minimal impact to the existing agriculture operations in the area.

#### 2.2Site Opportunities

This site is remarkably scenic and easily accessible to water sport and activity with no investment from the MD. Lots created on this site will highly desirable, quality development can be achieved.

#### 2.3 Landscape and vegetation

The land is stable and mostly level with a slight slope to the Waterton Reservoir. See attached map. The Current berm is in place to protect again spring runoff. Vegetation consists mainly grasses.

#### 2.4 Drainage

There will be a minimal amount of alteration to the current landscape that will affect existing drainage. minimal amount of the development will be made through roadways and buildings, that will not have a negative effect on surrounding areas.

#### 3. Planning and Polices.

#### 3.1 Plan Concept

The intent of this plan is to provide a seasonal campground that allows for the enjoyment of water sports/activities of Waterton Reservoir, fishing in Cameron Creek and the beautiful prairies to Rockies landscape.

#### 3.2 Roads

The safe and efficient use of the nearby highway provides excellent and easy access to the area.

#### 3.3 Plan Standards

- a. Site envelope: No permanent structures
- b. Roads: Dirt roads with addition of gravel will be used to outline campsite roadways. They will be maintained to ensure safe and easy access to lots and highway.
- c. Storage: Unit storage during the off season, will be available. Proper security measures and environmental conditions will be taken into consideration.
- d. Pets: Non-Aggressive dogs are welcome providing they are always tethered and attended to. Failure to comply will result in eviction from the campground.

#### 4. Servicing Requirements

#### 4.1 Lot access

Access to the campground will be obtained from the existing highway.

#### 4.2 Sewage disposal

Sewage (black and grey water) will be taken off site to a permitted dumping station.

#### 4.3 Water

Water storage will be internal tanks located in campers, and rain collection tanks. Potable water will also be available via water truck on a weekly basis to meet the demands and provide enough for campers during their stay. Water rights will be applied for. For irrigation, basic cleaning and emergency services via ground water well.

#### 4.4 Electrical services

Electrical services will be provided by Fortis.

#### 4.5 Garbage storage and disposal

Garbage will be stored on site within bear proof containers. Garbage will be disposed offsite at an approved dumping station as needed.

#### 4.6 Fire Protection

The campground will adopt the 'FireSmart Manual" supplied through Alberta Sustainable Resource Development.

#### 4.7 Communications

There are several cell towers within range of this site and provide excellent cell service.

#### 4.8 Bear Smart

There are ongoing bear smart programs in the adjacent areas. It is proposed to adopt similar practices from information available through Alberta Fish and Wildlife.

#### 5. Development Plan

#### 5.1 Objectives

The Waterton Dam Campground will give the opportunity of camping and boating that is in high demand in the area.

- Promotes a family friendly, out environment, with access to water sports.
- Spacious annual campsites





This letter is presented as a token of support on behalf of the Town of Falher towards the Royal Canadian Mounted Police (RCMP) and also as a motion of opposition to the Provincial Government's recent proposal for an Alberta Provincial Police Force.

Upon review of information made available by AUMA it has become abundantly clear to our entire council that blindly forging forward would come at an enormous cost to our province, and specifically its residents. The newly established Police Funding Model has already delivered a hit to small rural urban municipal budgets with a relatively small impact felt in terms of day to day deliverables in our communities. Continuing with a Provincial Police Force would come at an exorbitant cost with no assurance with a benefit in service.

Just today, S&P Global Ratings has downgraded Alberta's credit rating from 'A+' to 'A' while cautioning that additional downgrades in the near future are very possible if new fiscal measures are not adopted in a post-COVID19 Alberta. The exploration of an Alberta based Police Force was merely financial as there is no evidence suggesting a dissatisfaction with the quality of service offered by the RCMP to the magnitude that would warrant such an expense. To ask any and all residents of this province to fund such an ill-advised endeavour can only be viewed as an un-sound decision based on an act of ignoring facts, and more importantly, the voice of Albertans.

With the Provincial Government's reduction into MSI funding over the next few years and considering the infrastructure maintenance investments that all Canadian municipalities face over the coming years, local government budgets are already being stretched beyond their limits. Where exactly does the Provincial government envision the funding of a Provincial Police Service coming from? Undoubtedly, they will ask municipalities to pay, ultimately forcing local councils to play 'bad cop' by increasing municipal taxes in order to fund Provincial downloading. It is our opinion that the Provincial government needs to seriously re-evaluate its priorities.

#### Re: Alberta Provincial Police Service (APPS)

At the Regular Council meeting for Improvement District No. 9 on May 13<sup>th</sup>, 2021, Council reviewed the plan proposed by the Government of Alberta to replace the RCMP in Alberta with a Provincial Police Service. Please be advised that the Municipal Council for ID9 is strongly opposed to the creation of this proposal. After reviewing the Fair Deal Panel's Report to Government (as well as the many letters currently circulating from Municipal elected officials) ID9 Council is voicing its firm opposition to the APPS. There are several particularly concerning items identified in the Fair Deal Panel's report, namely:

- the Fair Deal Panel's recommendation to proceed with developing a proposal for a Provincial Police Force, despite only 35% of Albertans believing the police force would contribute to the desired outcome of helping Alberta better assert itself with the Canadian federation.
- Provincial and municipal governments possibly absorbing \$112.4 million policing costs currently covered by the federal
  government (which would be in addition to the increasing policing costs incurred by municipalities under the Police Funding
  Model).

Furthermore, and perhaps most importantly, we have an excellent relationship with our local RCMP detachment and feel no need to replace them with a Provincial force. The RCMP in Lake Louise and Banff have always been responsive to community needs and feedback, and have consistently delivered professional, quality public safety services in our communities. In addition, ongoing collaboration between both Detachments and ID9 Council has resulted in a positive and adaptive presence in the region.

We have not been provided with adequate proof that the formation of the APPS would result in better outcomes for Albertans, especially when considering the increased costs to our rate payers. ID9 Council is urging the Government of Alberta to listen to Municipal Leaders as well as the results of the Fair Deal Panel's report and shift efforts to improving RCMP relationships and resources in the Province. Please do not hesitate to contact me with any comments or concerns.

#### Minister,

On behalf of Smoky Lake County Council, I am writing to express our ongoing support for the Royal Canadian Mounted Police (RCMP) as our province's police force. In doing so, I note that we are joining dozens of other rural and urban municipalities in expressing deep concern at the prospect of replacing the same with an Alberta provincial police service (APPS), which the province is currently studying.

During your presentation at the AUMA/RMA Policing Summit in February of 2021, you spoke of Albertans "demanding democratic, community—based policing, a renewed commitment to improving policing in the province, and the need for police to work with community partners and citizens to ensure effective community policing." Minister, I am pleased to say that our community enjoys democratic, community—based policing. Our local RCMP detachment meets with us regularly as part of their commitment to optimal two—way communication that invites, welcomes, and listens to our input, and our detachment also works with our municipality and our citizens as community partners.

The Policing Transition Study being undertaken by our province is in response to the Fair Deal Panel's (FDP recommendation #14: Create an APS to replace RCMP. The FDP reported that 68.5% of respondents were) from Calgary and Edmonton regions. Calgary and Edmonton have their own police services, which should be considered when studying the transition from the RCMP. Another FDP finding was that only 35% of respondents supported the idea of creating an APS.

Finally, in the Alberta Police Federation survey from October of 2020, it was found that "replacing the RCMP is viewed as a least helpful measure tested to improve Alberta's place in Canada." Only 8% say replacing the RCMP helps a lot, only 6% support replacing the RCMP, 81% of Albertans

served by RCMP are satisfied with the service they receive, and 70% of Albertans oppose replacing the RCMP with an expensive new provincial police service.

There is so much convincing support for the RCMP in Alberta, and, with the strong and effective RCMP that serve us well in Alberta. Our Council supports the programs, initiatives, and progress of the RCMP in meeting our community's policing demands. We certainly have not seen compelling evidence that replacing the RCMP would result in better outcomes, particularly considering potentially increased operational (and transitional) costs.

Direct consultation with municipalities regarding the creation of an APPS has been inadequate. If municipalities who are served by RCMP detachments are excluded from this conversation, valuable information and feedback is left.

The Alberta Government already implemented a new police funding model which requires that communities under 5,000 such as ours are already increasingly paying <u>substantially</u> more for policing. Continually doing more with less is untenable.

In closing, I again reiterate our Council's support for the RCMP remaining as Alberta's police force. Smoky Lake County enjoys a positive and collaborative relationship with our local RCMP detachment, and we hope that the province will heed the concerns of many communities, rescind the ongoing study, and instead focus on other more productive options moving forward.

On February 16, 2021 Bill C-21, a bill that makes changes to the Criminal Code and the Firearms Act, and targets law abiding firearms owners, was introduced and is being debated in the House of Commons. Conservatives constituently call for cracking down on illegal gun smuggling, trading, gang and crime gun use, but Bill C-21 misses the mark if the aim really is to improve and protect the personal and public safety of Canadians. Bill C-21 focuses on the wrong people and groups, while also creating uncertainty and adding undo pressure on other levels of government.

Bill C-21 includes provision to allow municipalities to create handgun bylaws, which would place conditions on federal firearms licenses relating to handgun use, storage, or transportation within municipalities that have passed such bylaws.

Residents in cities and other places, with ever increasing gang shootings and violence rightfully expect their government ought to be taking action to keep them safe, but a regulation that gives municipalities the ability to pass bylaws does not do that. The municipal provision in Bill C-21 would be a bylaw on licenses, so this measure literally, specifically, and only targets Canadians who have licenses. This does nothing to stop dangerous criminals who certainly would never comply with a municipal bylaw when they do not obtain their guns legally, do not get licenses and who frankly do not care about criminal laws. What this purposed municipal bylaw section would do is lead to yet another layer of confusing, overlapping regulations and a patchwork of rules for already law-abiding Canadians within and between communities, while violations could result in two years imprisonment or permanent license revocations.

I have been hearing from municipalities concerned with being tasked by the Federal government to create these types of bylaws. They are sharing fears about economic and housing impacts by the perception that one community has higher safety standards than others, or that law-abiding firearms citizens will literally be unaware they are in violation just by crossing a municipal boundary that has different bylaws.

Some municipalities are saying that they do not have the expertise to create these bylaws and certainly would not have the resources to enforce such regulations. They are also concerned these bylaws potentially violate their own provinces' jurisdiction. Some provinces in opposition to the federal legislation have already passed or are proposing laws that would prohibit this type of power to shift to individual municipalities. Saskatchewan has already passed such a provincial law, and Alberta's bill received royal assent on April 29, 2021.

Due to these concerns, some municipalities have already opposed Bill C-21 and have taken the steps to pass resolutions in opposition to this potential new power that they neither requested, nor have the resources to impose and enforce.

I have attached a copy of the resolution passed by the council in Kingsville, Ontario. I encourage you to seek feedback from your rate payers, and to discuss this issue in council. You may decide to pass a similar resolution on behalf of your community. Please feel free to advise my office if you do so, and to reach out if you require any additional information on Bill C-21.

AND WHEREAS law abiding Kingsville residents who own legal handguns have already been thoroughly vetted through the CFSC, PAL and ATT applications;

AND WHEREAS illegal gun owners and smugglers do not respect postal codes;

AND WHEREAS if one municipality enacts a ban and not a neighbouring municipality, this will create a patchwork of by-laws;

AND WHEREAS a municipal ban would be difficult to enforce and easy to get around.

NOW THEREFORE BE IT RESOLVED that The Corporation of the Town of Kingsville is OPPOSED to the adoption of any by-laws restricting the possession, storage and transportation of legally obtained handguns;

AND BE IT FURTHER RESOLVED that this resolution be forwarded to the following public officials: MP Chris Lewis-Essex, MPP Taras Natyshak-Essex, Premier of Ontario The Honourable Doug Ford, Leader of the Official Opposition Andrea Horwath, Prime Minister of Canada The Honourable Justin Trudeau, and Leader of Official Opposition The Honourable Erin O'Toole."

In solidarity with the Mississaugas of the Credit First Nation, Stand With Asians Coalition (SWAC) is calling on the Mayor and Council to lower flags in all municipal buildings, fire halls, police detachments and school district buildings for 215 hours (9 days) in the month of June. We also ask that your municipality support the creation of a shoe memorial to commemorate the 215 First Nations children whose remains were found at the site of the former Kamloops Indian Residential School, in British Columbia, that was run by the Catholic church and operated between 1890 and 1969.

The horrific discovery of the remains of 215 children by the Tk'emlúps te Secwépemc First NationTerritory once again reminds us of the shameful atrocities and cultural genocide committed against the Indigenous people in Canada. Shoe memorials have been set up in large cities such as <a href="Vancouver">Vancouver</a> and <a href=Toronto</a>. Residents in your city should not have to travel hundreds or thousands of kilometres to commemorate the loss of these precious children.

SWAC is asking you and your council to immediately identify and establish a prominent location in your municipality so that your residents can place donated children's shoes. Please set up the shoe memorial site for the month of June for 215 hours (9 days). After the 9 days, we ask that you arrange for the donated shoes to be given to local charities.

Thank you for your kind consideration of this call to action.

  - 1. Equal Voice offers an online course that provides practical tools for women interested in running for public office.
  - 2. The Essential Guide to Being Elected: Increasing Women's Representation is a guide that is filled with practical advice from readiness to run, finances, nominations, social media to developing a team
  - 3. Municipal Elections in Canada: A Guide for Women Candidates is a campaign guide that has instructions and best practices around deciding to run, campaign literature, social media, media relations, and campaign financing.

#### RE: Proposed Alberta Coal Restriction Policy

Your input on the future of the Eastern Slopes of the Rockies is important to the long-term health of our water resources and their ability to provide clean drinking water to all communities in the Province. The Town of High River remains concerned about the negative impacts coal mining will have on our communities, landscapes, our water resources and future generations. We are requesting your support for our version of a new policy that reflects our desire to protect the Eastern Slopes and our water resources in perpetuity.

The Town of High River has met with the Coal Policy Committee and agreed to prepare a framework that would see coal exploration and development banned along the Eastern Slopes. At our May 10, 2021 Regular Meeting, Council unanimously supported the wording outlined below and we are requesting all Alberta Municipalities join us in supporting the proposed policy

Specifically, the Town's proposed <u>Alberta Coal Restriction Policy</u> would be effective November 15, 2021 and has three key principles:

- No further coal exploration or development will be permitted on the Eastern Slopes of Alberta. There will no longer be categories within this area and, instead, there would only be one area defined today as the Eastern Slopes.
- 2. Existing coal mining operations in the Hinton / Grande Cache areas will be permitted to retire gracefully.
- 3. Reclamation of lands disturbed by coal exploration activities with coal exploration permits issued prior to February 8, 2021 must be reclaimed no later than December 31, 2025.

Our rationale for the three principles of the Alberta Coal Restriction Policy are as follows:

- 1. The inherent value of the Eastern Slopes only exists with the landscape remaining intact.
- 2. The headwaters and landscapes of the Eastern Slopes are critical to the future of our province. Our communities, agriculture production, food production, tourism and recreation all rely on these landscapes existing and their watersheds producing clean water. Water is a limited resource that we all require to exist. The Town is strongly opposed to any activity that increases the likelihood of water contamination. Once a waterway has been contaminated by coal mining, this action cannot be reversed. Our future generations depend on us protecting this resource.
- 3. The negative impacts on the environment, human health, animal health and existing economies far outweigh the new jobs, taxes, royalties or economics that may be generated as a result of coal development in this area.

The Town will collect all feedback received and report back to the Coal Policy Committee in July 2021.
