REQUEST: Ask Council what next steps or information Council would like to see coming forward

BACKGROUND: Public Works performed a lifetime operating cost analysis on 4 of their own graders (\$117.55 lifetime average operating cost) and reached out to 2 different county/MD's to inquire about their contracted road maintenance program.

Knee Hill County:

- 3000km of road divided in 10 divisions
- In 2018 the county put a tender out to contract their road maintenance in 3 divisions, all 3 graders were provided by the same company at \$135/hrs. (See attached contact agreement).
- Director of infrastructure stated that this experiment was basically a flop and the contact was terminated early due to several challenges including lack of control, extremely low level of service and extra charges
- Currently, all divisions are serviced by an internal fleet of 12 160m graders
- It was also mentioned that the hourly rates would most likely be considerably higher today with the increase of the price of equipment, fuel and maintenance

MD of Bighorn:

- Quite different in size and road network than MD of Pincher Creek, they have approximately 240km of road with some leased for industries
- Do not own any equipment and do not have any infrastructure/shops to support a public work department and a maintenance yard
- It would be quite costly for them to acquire equipment, facilities and personnel to service just a few hundred meters of road

Administration Guidance Request

• Currently contract with Volker Stevin to service the entire MD with road maintenance and snow removal with rates for graders at \$165/hrs. not including extra charge rates

Both of these counties are using the same size of grader we are (160M) and both agree that contracting road maintenance reduce the level of service, response time and the control of quality.

FINANCIAL COMPARISON:

Alberta Road Builders Association (\$256.80) - MDPC (\$117.55) x 10 graders at 1000hrs yearly average = \$1,392,500 in saving internally excluding extra charges

Knee Hill County 2018 Rates (\$135.00) - MDPC (\$117.55) x 10 graders at 1000hrs yearly average = \$174,500 in saving internally excluding extra charges

MD of Big Horn (\$165.00) - MDPC (\$117.55) x 10 graders at 1000hrs yearly average = \$474,500 in saving internally excluding extra charges
